The goal of DWS's investment in European non-investment grade debt funds, which may be funded by principal interest, is to earn above-average returns, with at least 70% of the fund's assets invested in global corporate bonds that were then non-investment grade. The non-investment grade covered bonds with BB+ grade and lower rating, including bonds with D grade and outstanding grade. Up to 30% of the fund's assets are invested in corporate bonds that do not meet the above criteria. Fund managers aim to avoid any currency risk in their portfolios relative to the euro (see the public note for details).

The fund categorisation is mainly based on Bloomberg company's fund categorisation and references SITCA's offshore fund classification as a basis. Each fund category should have at least 10 funds before being evaluated.
