'Survived 2025'

Bumpy recovery, but gradual momentum is building

The UK economy has navigated a challenging backdrop in 2025, marked by slowing growth, heightened GILT market volatility and persistent geopolitical uncertainty. Against this backdrop, real estate investment activity remained subdued as investors continued to adopt a cautious 'wait-and-see' stance. Following some price recovery in 2024, prime yields held largely stable through 2025, with notable exceptions in London City offices and select retail segments.

We anticipate the recovery to gain pace through 2026. While inflation remains above the Bank of England's target, weak labour market signals and muted economic growth may point to further monetary easing. Greater clarity on fiscal policy should bolster investor confidence and as financing costs decline, yield compression presents an upside risk.

Headwinds persist but select opportunities exist

Currency hedging and higher debt costs continue to weigh on returns for euro-based investors, leaving UK real estate underperforming other core European markets on a risk-adjusted basis. Nevertheless, we believe that selective opportunities may exist. Resilient fundamentals and a limited development pipeline, particularly across the living sectors, underpin income growth potential. For investors adopting an active asset management approach, attractive pricing offers scope to generate potential alpha in segments such as Central London offices and multi-let industrial.

Office: London's global edge enables higher risk strategy

London's position as a dynamic gateway city, with exceptional access to talent, makes it highly attractive for innovative, high-productivity firms. To retain talent, these companies increasingly prioritise central, well-connected submarkets. While we expect 'best-in-class' offices in central locations should continue to perform strongly, we see a growing opportunity to acquire well-located, mid-quality assets.

With light refurbishment, Grade B office stock could be upgraded to a 'Grade A minus' standard, thereby potentially unlocking additional value through the rebasing of rents. This strategy applies to the core West End and City submarkets, both supported by robust fundamentals and a constrained development pipeline. That said, given a comparatively higher entry yield, we expect the city to benefit most from yield compression and therefore potentially deliver stronger returns over the forecast period.

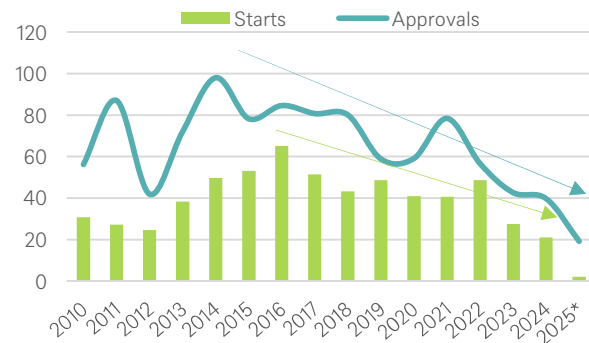
Residential: London for value-add, regions for core income

The UK build-to-rent sector currently remains supported by structural undersupply and defensive fundamentals. Despite government initiatives, housing delivery continues to fall short of targets. In London, viability challenges, exacerbated by the Building Safety Act, have curtailed development. This

backdrop may favour value-add strategies such as refurbishment, repurposing and developer partnerships to deliver much needed living space, including build-to-rent and affordable housing, alongside operational residential formats such as PBSA and co-living.

For core income, select regional cities could offer compelling fundamentals and comparatively attractive pricing. Cities such as Glasgow and Bristol, for example, are forecast to deliver strong household and disposable income growth yet are currently priced at up to a one hundred basis point discount to London. Additionally, greater affordability in these markets provides scope for further rental uplifts.

Logistics: Multi-let offers a core alpha return profile

Amid ongoing global trade uncertainty, a selective approach to UK logistics is warranted. Multi-let assets remain defensive and resilient, supported by tenant diversification and limited speculative supply, which has kept vacancy low. Shorter leases and rolling tenancies allow landlords to capture rental growth more effectively, particularly with active asset management. We favor well-connected schemes, near key urban hubs.

For core income investors, UK Big Box logistics may offer relatively attractive pricing, though fundamentals have softened, making location selection critical. The Golden Triangle remains a prime hub given its extensive population reach, large and cost-effective labour pool and central location. Meanwhile, regions such as the West and the North-West of England may benefit from increased defence spending, supporting existing defence clusters.
