

## 2026 Estimated Capital Gains Distributions

It is important to note that no amounts will be provided for distributions attributable to net investment income. With these capital gain payments, please keep in mind the following:

- \_ Amounts shown are "per share". To calculate your capital gain distribution, multiply the per-share amounts in the chart by the amount of shares you own. Your final capital gain distribution will be based on the number of shares you own on the fund's record date.
- \_ Prospective investors should consider purchasing shares after the record date in order to avoid a tax liability on gains their shares did not earn.

Per-share amounts are based on the estimated number of shares outstanding on the funds' record date.
