

American Jobs Creation Act Qualified Interest Income (QII) Percentages for the Xtrackers Funds 2025

Non-Resident Alien (“NRA”) shareholders are normally subject to a 30% (or lower tax treaty rate depending on the country) NRA withholding tax on ETF dividend income and short-term capital gain dividends paid by a mutual fund, unless such dividends are designated as exempt from NRA withholding tax. The percentages of distributions that have been identified by the Xtrackers Funds as exempt from NRA withholding are disclosed in the table below.
